To be aware of the applicable regulations and, in particular, Article 25 of Law 17/1997 on public entertainment and recreational activities, by which minors under 16 years of age may access a live musical performance held in cocktail bars, these being under their sole care, guardianship and responsibility.
2. To accompany minors, from the moment of access to the facilities until the exit of the same. In addition, to remain with them inside during the entire duration of the performance and ensure that all carry their personal identification at all times.
3. Avoid any type of illegal conduct carried out by minors (consumption of alcohol, drugs, violent attitudes, etc.), who will always respect the rights of the rest of the attendees. To take care of the well-being and physical integrity of the minors, taking care of them in the event of any problem of any kind.
4. To take care of any damage that the people in their charge may undertake during the event, both personal and material, always ensuring the proper use of the facilities and their maintenance.

5. To respect the indications of the persons in charge regarding any issue related to the musical performances.
6. To be aware that failure to comply with any of the above points may result in the expulsion from the premises of both the person signing this authorization and his or her dependents, without being able to claim the amount paid.
7. That Singtime IB, SL is exempted from any responsibility derived from the access of said minor to the above mentioned enclosure, as well as any other damage, harm and/or responsibility that the minor may suffer.
